Strategic Initiatives



Purpose and Recommendation

Council is requested to adopt Massage Manager License fees as established the recent revision of Mesa City Code Title 5, Chapter 12, "Massage Establishment Operations".

Background and Discussion

Council adopted a new Title 5, Chapter 12 of the Mesa City Code related to massage establishments on December 7, 2009. This resolution will set the fee for the new Massage Establishment Manager License that was established in the revision.

The Managers License fees proposed are:

Application Fee	\$ 50
Initial License Fee	\$ 25
Annual Renewal Fee	\$ 25
Renewal Late Fee	\$ 15

An additional fee to the City's third-party provider for fingerprint and investigation also applies.

Alternatives


Council could choose to amend the fee proposed. Council could also choose not to adopt a fee, in which case licenses would be issued at no charge.

Fiscal Impact

Revenue from this fee will vary depending on how many managers an establishment has. At approximately 120 establishments, using two managers per establishment, the first year fees would total \$18,000. Subsequent years' renewal fees would total \$6,000.
