**Subject:** Left Turn Prohibition  
48<sup>th</sup> Street at Superstition Ranch Market Private Driveway

### Purpose and Recommendation

To help alleviate congestion and traffic backup on 48<sup>th</sup> Street and Main Street and to reduce the potential for conflicts with cross traffic at the driveway, staff recommends prohibiting eastbound left turns from the driveway of Superstition Ranch Market located on the west side of 48<sup>th</sup> Street with centerline approximately fifty five (55') feet south of Main Street. See Figure 1.

### Background

The Superstition Ranch Market is located on the southwest corner of the intersection of Main Street and 48<sup>th</sup> Street. Forty Eighth Street adjacent to the Superstition Ranch Market is a 35-foot wide collector street with one travel lane in each direction and an exclusive northbound left turn lane. The posted speed limit is 25 mph and parking is prohibited.

The Ranch Market has two driveways on Main Street and one driveway on 48<sup>th</sup> Street. The driveway on the west side of 48<sup>th</sup> Street is approximately 55-feet south of Main Street. The driveways on Main Street are 460-feet and 225-feet west of 48<sup>th</sup> Street.

Staff received a request from a citizen to review the traffic conditions at this driveway. Staff monitored traffic conditions during the Ranch Market's peak hours of activity. Staff observed that many drivers making an eastbound left turn block cross traffic on 48<sup>th</sup> Street while waiting for the signal at Main Street to turn green. This causes congestion and traffic back up on 48<sup>th</sup> Street which then overflows onto Main Street. The traffic overflows obstruct eastbound through traffic and westbound left turning traffic on Main Street.

Staff contacted the Superstition Ranch Market to discuss the proposed turn prohibition. The owner of the Ranch Market informed staff that eastbound vehicles at this driveway also create congestion onsite during the peak hours of activity. The owner of the Ranch Market concurs with staff's recommendation to prohibit eastbound left turns from the driveway on 48<sup>th</sup> Street.


In order for Police to enforce the turn prohibition at this driveway, the left turn must be prohibited in City Code, and "No Left Turn" signs properly posted.

### **Alternatives**

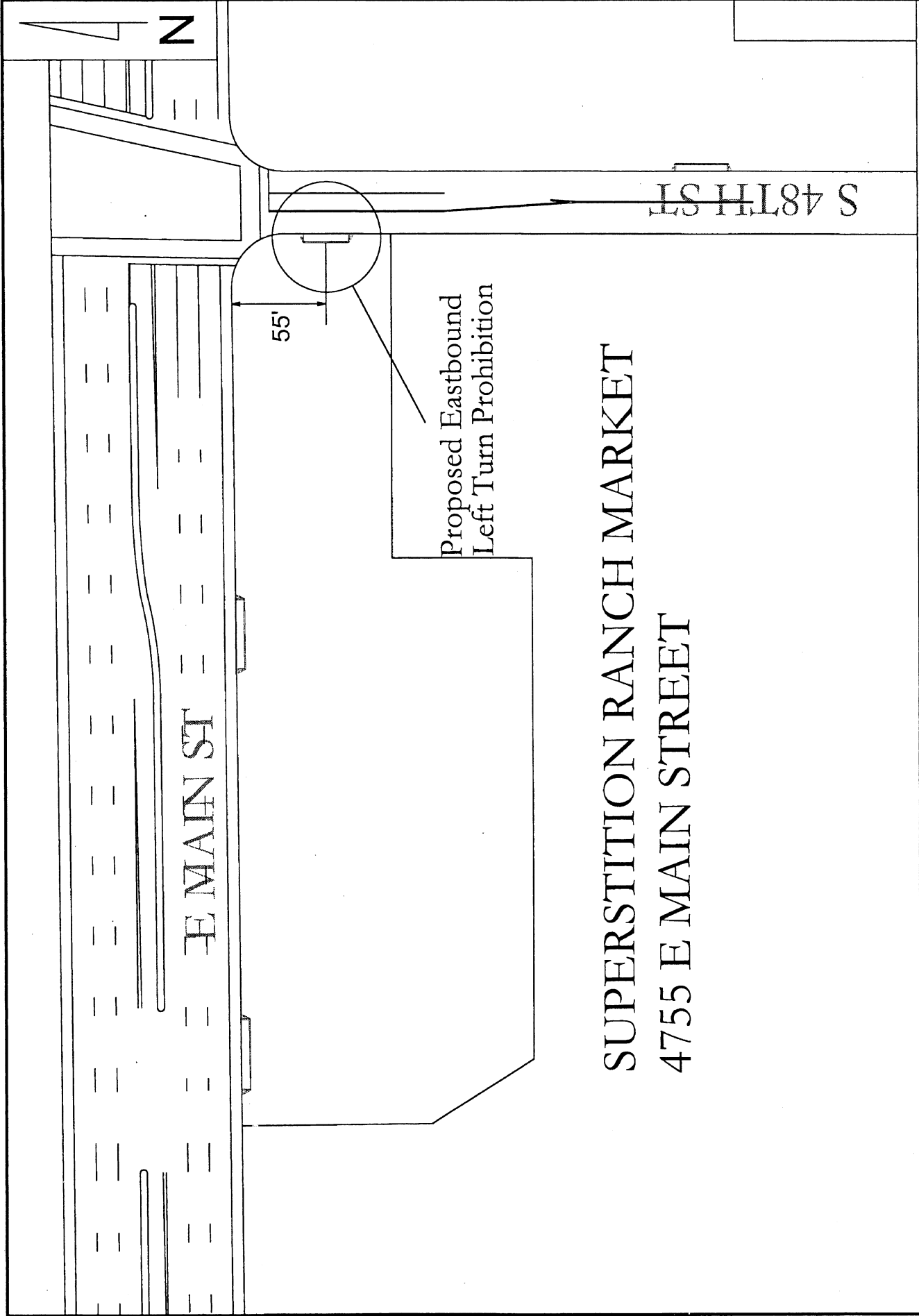
One alternative is not to approve the left turn prohibition. However, it would not address congestion and traffic backups on 48<sup>th</sup> Street and on Main Street or reduce the potential for conflicts with cross traffic at the driveway.

### **Fiscal Impact**

A total of two signs will be required to prohibit eastbound left turns at a cost of approximately \$200.

ORDINANCE NO. \_\_\_\_\_

AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF MESA, ARIZONA AMENDING SECTION 10-3-15 OF THE MESA CITY CODE REGULATING TURNS FROM DRIVEWAYS WITHIN THE CITY LIMITS OF MESA; AND PROVIDING CIVIL SANCTIONS FOR THE VIOLATION THEREOF.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF MESA, MARICOPA COUNTY, ARIZONA, AS FOLLOWS:

Section 1: That Section 10-3-15 (B) of the Mesa City Code is amended by inserting the following provision in alphabetical order and thereby not permitting left turns from the driveway on the following street:

**48<sup>TH</sup> STREET                      THE WEST SIDE FROM DRIVEWAY WITH CENTERLINE APPROXIMATELY FIFTY FIVE FEET (55') SOUTH OF MAIN STREET;**

Section 2: Civil Traffic Violations: Any violation of or failure or refusal to do or perform any act required by the provisions of this ordinance or of the Mesa City Code as amended herein shall constitute a civil traffic violation.
