CIVIL TRAFFIC SANCTION SCHEDULE

Listed below are VIOLATION CODES with sanction amounts which apply if paid before your hearing date. Mandatory State surcharges are already included. If payment for sanction is not received by your court appearance date, you will be in default and will be required to pay \$90.00 in addition to your sanction amount. Failure to pay on time may also result in suspension of your driver's license.

Mail or present notarized letter from legal guardian to have ticket dismissed.

INSURANCE VIOLATIONS

A.R.S. 28-4135A to 28-4135C \$1004.00

For the charges listed above, if insurance was valid on the date and time of the violation, mail or present that proof of insurance and the violation will be dismissed.

If you obtain insurance after the date of the violation, mail or present valid proof of a MINIMUM OF SIX MONTHS INSURANCE with a certified or uncertified copy of your driving record from MVD and the sanction may be reduced to

If proof of insurance and a certified or uncertified copy of your driving record from MVD is not provided, the driver license, vehicle registration, and license plates will be suspended.
