NOTICE IS HEREBY GIVEN that sealed bids will be received until Thursday, March 19, 2009 at 2:00 p.m. All sealed bids will be received at **Mesa City Plaza Building, Engineering Department at 20 East Main Street, 5th Floor**, Mesa, Arizona; except for bids delivered 30 minutes prior to opening will be received at the information desk, 1st floor, Main Lobby of the Mesa City Plaza Building. Any bid received after the time specified will be returned without any consideration.

This contract shall be for furnishing all labor, materials, transportation and services for the construction and/or installation of the following work:

Furnish and construct approximately 12,000 square-foot Fire Station, and other work as necessary to complete the Project in accordance with the Contract documents.

This contract excludes the installation of systems furniture and installation of telephone, data and CATV cabling in the building, which are by separate contract with the City of Mesa and/or by City of Mesa forces.

Contractors desiring to submit proposals may purchase sets of Plans, Special Provisions and Bid Proposal from ScottBlue Reprographics at 133 West 1st Avenue, Mesa, Arizona, for a non-refundable cost of **\$68.00** per set, regardless of whether the Contract Documents are returned. Copies of Contract Documents are available for viewing at the Engineering Department office. *Please call 480-644-2251 prior to arriving at the Engineering Department to ensure the documents are available for viewing (2 sets available).*

Work shall be completed within two hundred and forty (240) consecutive calendar days, beginning with the day following the starting date specified in the Notice to Proceed.

Bids must be submitted on the Proposal Form provided and be accompanied by the Bid Bond for not less than ten percent (10%) of the total bid, payable to the City of Mesa, Arizona, or a certified or cashier's check. **PERSONAL OR INDIVIDUAL SURETY BONDS ARE NOT ACCEPTABLE.**

The successful bidder will be required to execute the standard form of contract for construction within ten (10) days after formal award of contract.

The successful bidder, simultaneously with the execution of the Contract, will be required to furnish a Payment Bond in the amount equal to one hundred percent (100%) of the Contract Price, A Performance Bond in an amount equal to one hundred percent (100%) of the Contract Price, and a Certificate of Insurance.

The right is hereby reserved to accept or reject any or all bids or parts thereto, to waive any informalities in any proposal and reject the bids of any persons who have been delinquent or unfaithful to any contract with the City of Mesa.
