ADVERTISEMENT FOR BIDS

NOTICE IS HEREBY GIVEN that sealed bids will be received until Thursday, June 11, 2009 at 1:00p.m. All sealed bids will be received at **Mesa City Plaza Building, Engineering Department at 20 East Main Street, 5<sup>th</sup> Floor**, Mesa, Arizona; except for bids delivered 30 minutes prior to opening will be received at the information desk, 1<sup>st</sup> floor, Main Lobby of the Mesa City Plaza Building. Any bid received after the time specified will be returned without any consideration.

This contract shall be for furnishing all labor, materials, transportation and services for the construction and/or installation of the following work:

Complete an underground bore of sufficient size to install two (2) each 4-inch electrical conduits. Install three (3) each switching cabinets, two (2) each electrical risers (partial); pull three (3) each 15kV URD electrical cables into one of the conduits. City will provide switching cabinets and will provide and install all termination materials.

**A pre-bid site visit has been scheduled for this project, see Special Provisions for details. Although this is not a mandatory meeting, all bidders are encouraged to attend.**

Work shall be completed within forty five (45) consecutive calendar days, beginning with the day following the starting date specified in the Notice to Proceed.

Bids must be submitted on the Proposal Form provided and be accompanied by the Bid Bond for not less than ten percent (10%) of the total bid, payable to the City of Mesa, Arizona, or a certified or cashier's check. **PERSONAL OR INDIVIDUAL SURETY BONDS ARE NOT ACCEPTABLE.**

The successful bidder will be required to execute the standard form of contract for construction within ten (10) days after formal award of contract.

The successful bidder, simultaneously with the execution of the Contract, will be required to furnish a Payment Bond in the amount equal to one hundred percent (100%) of the Contract Price, a Performance Bond in an amount equal to one hundred percent (100%) of the Contract Price, and a Certificate of Insurance.

The right is hereby reserved to accept or reject any or all bids or parts thereto, to waive any informalities in any proposal and reject the bids of any persons who have been delinquent or unfaithful to any contract with the City of Mesa.
