NOTICE IS HEREBY GIVEN that sealed bids will be received until Thursday, April 8, 2010 at 2:30 p.m. All sealed bids will be received at **Mesa City Plaza Building, Engineering Department at 20 East Main Street, 5th Floor**, Mesa, Arizona; except for bids delivered 30 minutes prior to opening will be received at the information desk, 1st floor, Main Lobby of the Mesa City Plaza Building. Any bid received after the time specified will be returned without any consideration.

This contract shall be for furnishing all labor, materials, transportation and services for the construction and/or installation of the following work:

Expand the existing pump station, including adding (1) 0.7MGD vertical turbine pump and motor, installation of variable frequency drives, replacing existing pump seals with mechanical seals, new valves, electrical and instrumentation improvements and other work as noted on the Approved Plans and Specifications.

Work shall be completed within thirty (30) consecutive calendar days, beginning with the day following the starting date specified in the Notice to Proceed.

The Contractor is advised there is a Pre-Bid Meeting scheduled for this project. See Special Provision 56 "Pre Bid Review of Site" for additional information.

Bids must be submitted on the Proposal Form provided and be accompanied by the Bid Bond for not less than ten percent (10%) of the total bid, payable to the City of Mesa, Arizona, or a certified or cashier's check. **PERSONAL OR INDIVIDUAL SURETY BONDS ARE NOT ACCEPTABLE.**

The successful bidder will be required to execute the standard form of contract for construction within ten (10) days after formal award of contract.

The successful bidder, simultaneously with the execution of the Contract, will be required to furnish a Payment Bond in the amount equal to one hundred percent (100%) of the Contract Price, a Performance Bond in an amount equal to one hundred percent (100%) of the Contract Price, and a Certificate of Insurance.

The right is hereby reserved to accept or reject any or all bids or parts thereto, to waive any informalities in any proposal and reject the bids of any persons who have been delinquent or unfaithful to any contract with the City of Mesa.
