ADVERTISEMENT FOR BIDS

NOTICE IS HEREBY GIVEN that sealed bids will be received until Thursday, February 25, 2010 p.m. 3:30 All sealed bids will be received at **Mesa City Plaza Building, Engineering Department at 20 East Main Street, 5th Floor**, Mesa, Arizona; except for bids delivered 30 minutes prior to opening which will be received at the information desk, 1st floor, Main Lobby of the Mesa City Plaza Building. Any bid received after the time specified will be returned without any consideration.

This contract shall be for furnishing all labor, materials, transportation and services for the construction and/or installation of the following work:

Remove approximately 110,000 SY of asphalt paving, re-shape and re-compact aggregate base course, and install new asphalt paving consisting of 2.5-inches of AC surface course over 3-inches of base course. Mill approximately 55,000 SY of existing AC pavement and overlay with new AC pavement. Remove and replace approximately 5,300 SF of concrete. Furnish and install sidewalk ramps, survey monuments, and pavement striping per plan, and additional items of work as necessary to complete the project in accordance with the Approved Plans and Specifications.

Contractors desiring to submit proposals may purchase sets of Plans, Special Provisions and Bid Proposal from ScottBlue Reprographics at 133 West 1st Avenue, Mesa, Arizona, for a non-refundable cost of \$36.00 per set, regardless of whether the Contract Documents are returned. Work shall be completed within ninety (90) consecutive calendar days, beginning with the day following the starting date specified in the Notice to Proceed.

Bids must be submitted on the Proposal Form provided and be accompanied by the Bid Bond for not less than ten percent (10%) of the total bid, payable to the City of Mesa, Arizona, or a certified or cashier's check. **PERSONAL OR INDIVIDUAL SURETY BONDS ARE NOT ACCEPTABLE. The following forms are to be submitted with the Bid Proposal for Federal-Aid Projects.**

- 1. Surety (Bid) Bond**
- 2. Non-Collusion Bidding Certification (See Proposal Documents and Forms)**
- 3. Certification with regard to performance of previous contracts**

The successful bidder will be required to execute the standard form of contract for construction within ten (10) days after formal award of contract.

The successful bidder, simultaneously with the execution of the Contract, will be required to furnish a Payment Bond in the amount equal to one hundred percent (100%) of the Contract Price, a Performance Bond in an amount equal to one hundred percent (100%) of the Contract Price, and a Certificate of Insurance.

The right is hereby reserved to accept or reject any or all bids or parts thereto, to waive any informalities in any proposal and reject the bids of any persons who have been delinquent or unfaithful to any contract with the City of Mesa.
