



Quail Run Sports Complex and Red Mountain Soccer Complex Field Rental Guidelines

Quail Run and Red Mountain Soccer Complexes will periodically have fields available for rental by the general public. The general timeline for availability is as follows:

- September through mid-December:
Some weekend availability
- Mid-December through April:
Weeknight and some weekend availability
- May through August:
Some weeknight availability and weekend availability- limited number of fields due to field maintenance

Quail Run Baseball and Softball fields general timeline for availability is as follows:

- September through mid-December:
Some weeknight and some weekend availability
- January and February:
Weeknight and some weekend availability
- March through mid-July:
Little to no availability due to Little League season
- Mid-July through August:
No availability due to field maintenance

This is the general overview of field availability. The City reserves the right to take fields down for maintenance if playability becomes compromised or dangerous.

Rental Requirements

- Minimum field rental requirements are 2 fields for 4 hours each.
- Reservations for the upcoming month are not taken after the 25th day of the current month. This is to accommodate the staff scheduling that occurs on a month-to-month basis.
- Reservations will not be taken more than 3 months prior to desired usage date(s).
- All user groups must have insurance policy of at least \$1,000,000 listing City of Mesa as Additional Insured on file at the time of reservation.
- All rental fees must be paid in full at time of reservation. Fees are as follows:
 - \$10 per field/hour for usage prior to 6pm
 - \$22 per field/hour for usage after 6pm (\$12 per field/hour for partner youth group usage)
 - \$17/ hour site supervision fee
 - \$30-90 per field (depending on layout) for preparation/lining fee (only City of Mesa personnel permitted to apply lines to Quail Run and Red Mountain sports fields). Fields will only be lined at the customer's request.
- Reservations must be completed at the Mesa Convention Center, 263 N. Center St. and will be taken on a first come-first served basis.
- Phone-in reservations will be accepted with a credit card.
- Contact person listed on permit must be on site entire time facility is being used.
- All renters agree to follow and enforce City of Mesa Ordinances and Park Regulations as well as Quail Run Sports Complex and Red Mountain Soccer Complex Use Guidelines.
- It is the contact person's responsibility to make sure all field usage ends on time.
- Failure to comply with rules of usage will result in suspension of facility usage and forfeiture of future use.
- Any renter who violates facility rules and, as a result, has their rental time cancelled on a given day has no opportunity for a refund of fees and charges paid for that reservation.
- **Periodically, there will be an open field available for rental during an already-occurring reservation. The City will reserve space on the field for practices only with the fees being \$10/hour during the day and \$20/hour (\$14/hour for youth partner play) during the evening (6pm and later).**
