## Purpose

On May 18, 2009, the Mesa City Council approved a recommendation to extend light rail on Main Street between Sycamore and Gilbert Road. Funding is available for constructing light rail as far east as Mesa Drive. Additional studies and funding need to be secured for the Mesa Drive to Gilbert Road section.

In addition to regularly planned outreach activities, a working group of stakeholders is being formed to provide input to the METRO and city of Mesa project team on key issues relating to Main Street configuration, pedestrian access, station location/architecture, system infrastructure and aesthetic considerations.

## Who should participate?

Interested business owners, property owners and residents bound by University to the north, Broadway to the south, Dobson to the west and Horne to the east should submit an application.

## What is my commitment?

The committee is tentatively scheduled to begin meeting in fall 2009 and continue to 2011. The committee will likely meet on a monthly or bi-monthly basis.
