Fireworks require special permits from the City of Mesa Fire Department.

If you are planning to have fireworks at your event, you are required to obtain a Fireworks Permit from the City of Mesa Licensing Office.

Fireworks and/or pyrotechnic special effects shall be permitted through the Licensing Office, Mesa Fire Department and the City Attorney's Office 14 days prior to the event start date. An inspection must be scheduled with the Fire Department **prior** to pyrotechnics being brought on site.

NOTE: Fireworks companies are aware that a separate application must be filed with the Mesa Fire Department. Applicant is responsible for providing a site plan consistent with the requirements of NFPA 1123 Code for Fireworks display.
